#### **General information**

Listed on the following pages are the most common courses. This is just an example and we will tailor your training to your personal requirements and schedule.

#### **Medical Requirements:**

Prior to your first solo flight you must obtain a Class III Medical Certificate or higher. Konect Aviation will assist you in finding a certified physician to administer the necessary examination. We help you through your complete training!

#### **Ground School:**

All students must pass the FAA written examination. You will receive one-on-one ground instruction with your certified flight instructor to prepare you for the written test. If you already hold a Private Pilot (Airplane) Certificate, you will not have to take another written test for helicopters.

#### **Pricing and Training:**

All training costs are current as of October 2010 and are subject to change due to changing fuel prices and other factors. Students will be notified of changing prices. All training costs shown are based on the minimum training hours required by the FAA. These prices vary depending on the students progress. FAA minimums must be fulfilled. You should anticipate training costs to be higher than the FAA required minimum. Konect Aviation suits their courses to every student to ensure the best training and to save you money.

Hourly costs for our aircrafts:

Robinson R22: \$255.- per hour incl. instructor Robinson R44: \$475.- per hour incl. instructor Cessna 172: \$155.- per hour incl. instructor

#### IFR included in commercial training:

By including your instrument training in your commercial training, Konect Aviation can give you more training at little additional expense. For example, by completing your instrument rating prior to your commercial check ride you will save money. This is because IFR training hours count towards the 150 hours requirement by the FAA for your commercial certificate. Many flight schools don't like you to do that but it is smart and saves you money!
